

## Jorlink's Pre-Owned Equipment Listing Agreement

In exchange for assistance in locating buyers of equipment listed by the client or "seller" as referenced below, the client or "seller," agrees to notify Jorlink USA, Inc., dba "Jorlink" within (10) days of the sale of that equipment. If Jorlink USA, Inc., hereafter referred to as "Jorlink", introduced the buyer of the equipment to the seller, this notification must include the names of the parties involved and the final sale price. It is also agreed that the sale price and the conditions of the sale are the responsibility of the seller. Jorlink is not responsible for inaccuracies in equipment descriptions, condition of the equipment, or its suitability for the intended application.

If the equipment listed is sold to a buyer referred by Jorlink, the seller agrees to pay Jorlink a referral commission of (25%) for the sale price of that equipment. Jorlink shall:

- Place the equipment on on-line EBay Store using our Power-Seller status and rating
- Advertise in trade-related publications
- Use our professional sales force for promoting brokered, listed equipment
- Offer new client (buyer) our service for maintenance/support
- Email potential clients from our vast database of industry contacts and potential buyers

Client\Seller shall:

1. Pay a listing fee of **\$69.95** for initial (3) month listing commitment paid by credit card.
2. Pay additional **(25%)** commission fee once equipment has been sold via credit card charge below. We will require your Minimum Sale and Asking Price for which depending on sold price, commission paid to Jorlink may be as follows:
